The CIP was a 5-year plan for the airport and updated annually. If projects were not included in the CIP, then the project would not be eligible for funding assistance from the state. Mr. Poe said the Airport Authority had already approved the plan. There were no other questions.

The meeting adjourned at 6:19 p.m.

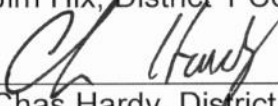

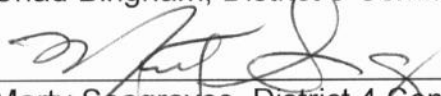


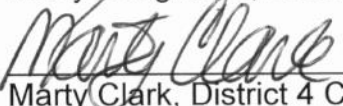
